### INVITATION OF PUBLIC COMMENTS

**Sub:** NHAI-PIU-NSK - Six Laning of Pimpalgaon-Nashik-Gonde section of NH-3 from Km 380.000 to 440. 000 in the State of Maharashtra - MJP, Nashik's proposal for laying 300 mm dia. Water Supply Pipeline from Km. 385.200 to Km. 386.800 (RHS) along NH-3 & crossing at Km. 386+800 across NH-3.

Executive Engineer, Maharashtra Jeevan Pradhikaran Division, Nashik vide letter cited above has submitted proposal for Laying / Crossing Water Supply Pipeline along / across NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the Laying of Water Supply Pipeline of 300mm dia. along NH-3 (Pimpalgaon-Nashik-Gonde Section) is proposed from Km. 385.200 to Km. 386.800 (RHS) & crossing at Km. 386+800 at Village Pimpalgaon (B), Tal. Niphad, Dist. Nashik.

3. As per Para-4 of Ministry Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
